測試方法： 本測試依客戶指定方法，取10 μ L菌液(約 1×10^8 CFU/mL)於玻片上，將樣品放置於距離玻片1公分處，並開啟樣品作用3秒鐘後，取出液體連續稀釋後各稀釋度取1mL放入玻片中並加入15~20mL TSA 混勻後於 $32.5 \pm 2.5^\circ\text{C}$ 培養5天。



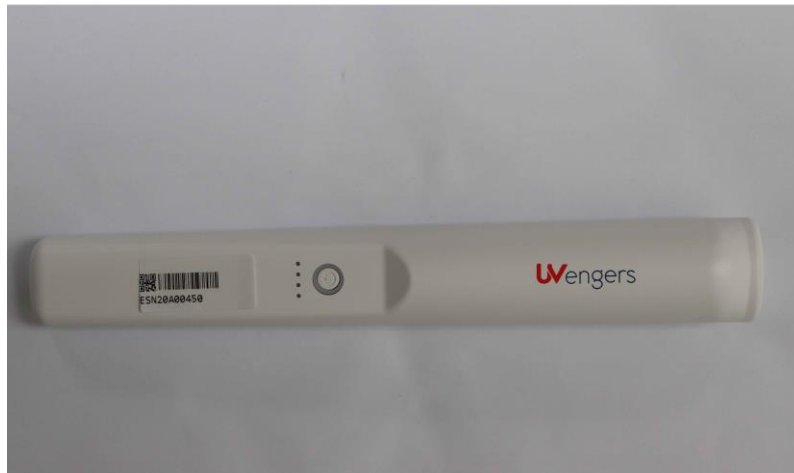
