Test Method : With reference to the client's specific method. Add 10µL (approximately 1×10^8 CFU/mL) bacteria solution on coverslip. Place the the sample about 1 cm above the coverslip. The sample was turned on for 3 seconds. Perform a serial dilution of the recovered liquid. 1 mL was added to each Petri dish and add 15 ~ 20mL TSA to mix and incubate at 32.5 ± 2.5 °C for 5 days.



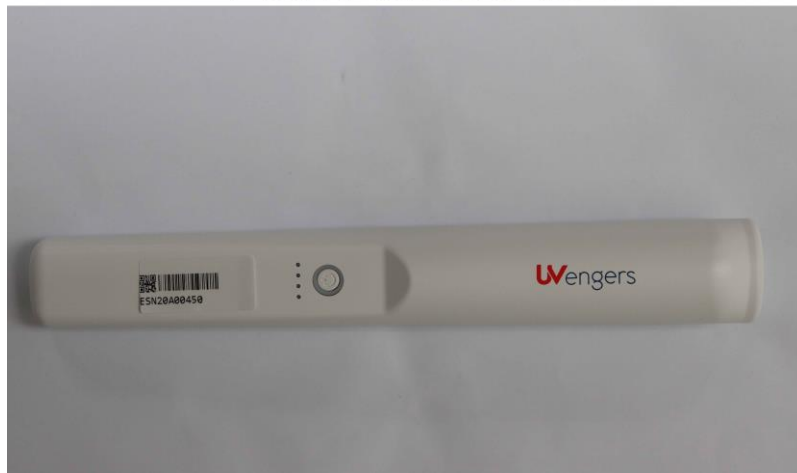
